Subject to the articles or any unanimous shareholders' agreement, the remuneration to be paid to the directors shall be such as the board of directors shall from time to time by resolution determine and such remuneration shall be in addition to the salary paid to any officer of the Company who is also a member of the board of directors.

A person who is the single director and shareholder of a proprietary company is to be paid any remuneration for being a director that the company determines by resolution (s 202C). It is in shareholders' interests to remunerate appropriately in order to attract the best calibre of person to serve on the board.

A board resolution (also known as a directors' resolution) is a formal document that records the decisions or intentions of board members on behalf of the corporation. Section 157A of the Companies Act states that the business of a company shall be managed by, or under the direction or supervision of, the directors .

A director is an employee of the company and the company may offer him or her a salary as part of a contract for service. A director's salary is approved by the board of directors. A director's salary must be disclosed and treated as an expense in the company's annual report.

Accordingly, a public company can pay remuneration to its directors including executive directors and non-executive directors within the limits of 11% of the net profits and this limits can only be exceeded with the prior approval of the members of the company by an ordinary resolution.

The rules regarding directors' remuneration are discussed in detail as follows: 1. The remuneration of directors is to be determined either by the articles of the company or by special resolution. 2. The amount and the mode of remuneration shall be in accordance with the provisions of section 198.

Rules regarding directors' remuneration of a company

A Directors' Resolution is a written record of an action or decision made by a company's board of directors. The resolution can be created with or without a formal meeting of directors. For instance, if a board of directors expressly agrees to an action, a written resolution can be drawn up without a formal meeting.
